TEA/19/822 APOLOGIES FOR ABSENCE

TEA/19/824 TO APPROVE THE MINUTES OF THE TOWN EVENTS & AMENITIES COMMITTEE HELD ON 28TH NOVEMBER 2018

TEA/19/825 TO RECEIVE A GRANT REQUEST FROM THE CLEVEDON PIER TOWARDS THE PIERS 150TH ANNIVERSARY

Committee Members discussed the grant request received. It was **PROPOSED, SECONDED and AGREED** to award the full amount of £5,000.00, on the proviso that the monies are taken from the 2018/19 budget only.

TEA/19/826 ITEMS ARISING FROM INFORMAL BUSINESS

826.1 NSC STREETS & OPEN SPACES UPDATE

Noticeboard on the promenade – Poster coverage on balance are replaced/replenished once a week. The Weston Pier and Playhouse have 40% each, leaving the Seafront and Event team with 20%; where the team can accommodate posters in Clevedon within the 20%. Six to eight weeks lead time is required ensuring coverage of an event. Ideally posters to be B2 in size and of a suitable quality.

Disabled Play Equipment – the new roundabout to be installed on the Salthouse Playing Fields in late February/March 2019.

The Ripple Path – Edward Road South to Woodland Glade – Awaiting confirmation from NSC as to schedule of works for the path.

Seafront Paving by Clevedon Sailing Club – A request to be submitted to NSC to ask for removal of the pile of broken slabs. Cllr Watkins to provide a photograph.

Path and steps behind Clevedon Promenade Bowling Club – A request to be submitted to NSC to follow this up as an urgent matter.

TEA/19/827 TO RECEIVE TEA COMMITTEE BUDGET UPDATE FOR 2018/19

Members noted the accounts that had been circulated.

TEA/19/828 TO RECEIVE AND DISCUSS THE TENDER QUOTES AND AGREE A NEW DOG BIN CONTRACTOR

Members discussed and considered the tenders received. The Committee agreed to seek further information and clarification on Companies, A, C & D before voting for a new contractor for the Town Council bins. **PROPOSED, SECONDED & AGREED** that voting on the new contractor will be by email.

TEA/19/829 TO DISCUSS AND AGREE TO THE SUMMER PLANTING SCHEME FOR THE TOWN FLOWER BEDS IN 2019

Members **AGREED** to a red, white and blue theme for the summer bedding plants. The badge bed by the bandstand to have a design with the numbers 1,5,0 to support and celebrate local groups that are celebrating their 150th anniversaries this year.

TEA/19/830 TO DISCUSS AND DECIDE WHETHER TO SUBMIT A REQUEST FOR SUMMER BEDDING PLANTS

Members **AGREED** to submit a request for 200 plants, to be planted in the Council office flower beds.

TEA/19/831 TO RECEIVE THE REPORTS FROM TOWN COUNCIL REPRESENTATIVES FOR OUTSIDE BODIES

Community Association – Cllr Francis-Pester reported the next meeting is to be held on 31 January 2019.

N Somerset Safety & Coastal Advisory Group – Cllr Giles-Townsend reported the end of season report showed that Clevedon received a 'Good' bathing water mark. On-going discussions with regards to ownership of the slipway.

Clevedon Civic Society – Cllr Hill reported there is a new Chairman elected. The society are celebrating their 50th anniversary this year. As part of their celebrations the Environment Group are to improve walkways in Alexandra Gardens.

Strode Leisure Centre User Group – Cllr Blades confirmed there are no issues to report.

Clevedon Pier Trust – Cllr Francis-Pester reported the Pier will be celebrating their 150th anniversary with the launch of some new facilities this year.

Clevedon Sailing Club Committee – No report.

Clevedon Twinning Association – Cllr Watkins reported the website is being refurbished.
CANS – No report.

Police & Communities Together – Cllr Hill reported that M&S store within the BP garage was targeted by out of town criminals. Vehicle crime has increased with people not locking their car doors. PCSO's have two electric bikes which has seen a positive effect in being able to get around the town quicker. Police van attends some Thursday Market days and is busy with enquiries from the public. More issues with the dark corner by Superdrug, Changing Lives in the evenings. PACT Suggested that the flower bed are cut down to ground level so that the CCTV camera has a better chance of capturing any incidents.

Gwilliam & Woodward Trust – No report.

MARLENS Trustees – Cllr Cherokoff reported that a shared defibrillator is to be purchased and kept at the Salthouse Public House. Mud clearing in the Marine Lake has been delayed until late Summer due to dealing with different authorities to gain permission in time for an earlier clean. A company is interested in making a film about rubbish in the sea with a local celebrity involving a lorry to dump plastic into the marine lake; finer details as to the clean up after, any damage etc., is being finalised. The lake would need to be closed for 2-3 days if it goes ahead.

Farmers' Market Co-Op – Cllr West has obtained the Farmers Market bookmark for market diary dates in 2019. The footfall at the Farmers market is not as it should be, more advertising is required.

Land Yeo Friends – Cllr Watkins reported a 'Two Rivers Walk' will be up and running this year. More clearance of the verges on both sides of Court Lane to be done. The trash screen by the Conservatives Club, which acts as a safety net against flooding, has finally been cleared by NSC just after Christmas. A request for the installation of a rubbish bin at Strode Road bridge to be re-submitted to NSC.
