**TEA/18/782 ITEMS ARISING FROM INFORMAL BUSINESS ABOVE;**

**782.1 NSC Streets & Open Spaces Update**

Mr Gareth Withers provided the following written updates:

- *Seafront Paving by Clevedon Sailing Club*  
This is being monitored by NSC.
- *Surface of Promenade near Little Harp Pub and Amusement Arcade*  
NSC are in the process of replacing the area concerned with ramps. Members of the Committee requested the area to be fenced off until the matter is resolved and queried the use of S106 monies.
- *Noticeboard on the Promenade*  
NSC advised that 80% of the board provision is covered by the Grand Pier in Weston. Members of the Committee requested clarification of the coverage periods for advertising, e.g. quarterly; to establish how frequently the adverts would be changed & whether local institutions could be included.
- *Badger bridge improvements on Poets Walk*  
NSC confirmed the bridge improvements are with Public Rights of Way. Members of the Committee requested a timescale for completion of the works.

Members noted the accounts that had been circulated. Clarification was sought on the Income and expenditure relating to the Tennis Courts resurfacing as only the grant income was shown.

**REGARDING NON-COLLECTION OF DOG WASTE FROM THE DOG BINS IN JULY 2018**

Members of the Committee requested details of other Parish Councils dog bin contract to ascertain how best to proceed with the contract renewal or replacement.
