PUBLIC PARTICIPATION

Mr Peter Templeton, Chairman of the Neighbourhood Plan Steering Group. Spoke to members on the report that had been circulated with the agenda and would be considered by the Council later in the meeting. He highlighted the areas the Neighbourhood Plan were concentrating on and which would be included in the draft plan that would be going out for the wider consultation at the start of the year, before going out for referendum. He went through the recommendations being proposed by the Steering Group to the Council. Members had the opportunity to question Mr Templeton on the report and his presentation. Members thanked Mr Templeton for his hard and dedicated work leading the steering group and driving the programme on consultation forward. Members noted that Mr Templeton was proposing to stand down as Chairman in January as he feels that the final stages should be led by a town councillor. The importance of the Neighbourhood plan in the wider planning strategy was reiterated, particularly in relation to CIL planning and funding.

Several Clevedon Residents expressed concern about the use of land at Brookfield Walk, adjacent to Hither Green for allotments explaining that the area is well used by dog walkers and children. A petition was handed to the Council signed by 209 residents. In a response it was explained that Clevedon is running out of burial land and if no suitable land is found to enable a land swap then within a few years residents would no longer be able to be buried in Clevedon. Members appreciated the concerns expressed by the residents but explained that the Council had to carry out the soil tests as part of the due diligence.

Cllr Hill expressed the Councils appreciation at the Chairman leaving her sick bed to attend the Town Council service at the memorial stone in Queen Square on Remembrance Sunday. There was a short discussion on the role of Councillors as unpaid volunteers in Council's civic events.

 BROOKFIELD WALK to remain as a designated Local Green Space and a Strategic Open Space (MM36, MM71, MM76). This is an essential green space in a town with a shortfall of green spaces see NSC report some years ago.

To reiterate previous comments;

- LAND NORTH OF CHURCHILL AVENUE Reiterate request that this remain as a public open space. (Schedule 1)
- MILLCROSS SITE In the event of the site not being used for a hospital request the site is used for affordable or social housing. A motion to add after hospital 'or other health facilities' was not seconded.
- LAND WEST KENN ROAD If part of this site is developed for housing request that at least 30% of the housing is affordable or social housing.

It was AGREED to consider the remainder of the document using the marked up version along with the comments received from the Clevedon Neighbourhood Plan Group at the next meeting of the Planning Committee on 25th October 2017 meeting. .

RESOLVED to defer this item till agenda item 8.5 the Planning minutes of 25th October.

TH 17/830 School Crossing Patrol. It was confirmed that to date the schools affected by the crossing patrol had not provided any additional funds to enable the retention after February 2018. Following a short discussion it was **RESOLVED 14 votes to 0** to note the minutes of the special expensed meeting held by NSC on 6th October 2017

17/864 TO DISCUSS AND AGREE A SUBSTITUTE TOWN COUNCIL REPRESENTATIVE ON THE MARLENS TRUSTEES; CURRENT REPRESENTATIVE CLLR C. HALL

Proposed, seconded and **RESOLVED by 12 votes to 0** to appoint Cllr B. Cherokoff as a substitute council representative on Marlens Trustees pending the return to full health of Cllr Hall.

Councillors expressed concern at Cllr Hall's long term absence and hoped to see him at the January meeting.

17/865 RECEIVE AN UPDATE REPORT FROM REPRESENTATIVES ON CLEVEDON CCT

Cllr Francis-Pester and the Chairman reported on the CCT meeting which had taken place the previous night. The Creative Hub and the Curzon Cinemas HLF/CCF funding bid was discussed, in line with a possible Town Plan. This had originally been suggested at the meeting earlier in the year with David Carter of NSC. This would be an overarching plan bringing all the Neighbourhood Plan, Economic Plan, Local plan for Clevedon under one document giving a 25 +year vision for Clevedon; this will be going to FGP.

17/866 RECEIVE AN UPDATE REPORT FROM THE NEIGHBOURHOOD PLAN GROUP

A report had been circulated with the agenda and members noted the information from the public session. There was concern expressed at the recommendation 2a & 2b. The Planning Committee can be mindful of the Neighbourhood Plan Vision and Objectives but it is not a legal document until after a positive referendum.

Proposed seconded and **RESOLVED** to suspend standing orders to enable Mr Templeton to speak

Mr Templeton explained that as the Town Council had implemented the formation of the Neighbourhood Plan, were the Accountable Body and as they had initiated the legal process they were the qualifying body so must lead the process.

Proposed, seconded and **RESOLVED** to reinstate the standing orders.

Proposed, seconded and **RESOLVED** by 15 to 0 to note the report.
