P/16/1432 COMMITTEE VICE-CHAIRMAN TO REPORT OF MEETING WITH NSC HELD ON 11TH OCTOBER 2016 CONCERNING INFRASTRUCTURE FOR NEW DEVELOPMENTS

The items put forward by the Town Council for discussion with regard to highways had been answered and this report would be considered by the Transport & Highways Committee at their meeting next week. All councillors have received a copy of the report.

Cllr Barton reported that the meeting had been with David Carter and Steven Thorne, who had emphasised that North Somerset Council's Core Strategy now requires 20,985 homes to be built in North Somerset up to 2026 and the consequent pressures on development and land availability. NSC is looking to local councils for local knowledge on transport issues and their ideas for mitigation. NSC had met with Nailsea and Portishead Town Councils previously and would like to meet again with individual town councils in six months' time. It was suggested that local councils work together on strategies for highways. Due to a lack of resources NSC is dependent on section 106 and CIL funding. Major infrastructure is reliant on funding from major developments. Clevedon does not have land available for large scale developments and the projected housing numbers for Clevedon are lower than other areas of North Somerset.

There had been some discussion about public transport and the reduction of services in Clevedon. It had been agreed that up to date timetables would be made available for the Town Council.

Committee members reiterated that Clevedon is affected by developments outside of the town boundary. Members generally felt that NSC should be looking at the cumulative effect of development on infrastructure rather than the effect of individual developments.
