NSC Streets & Open Spaces Update items;

- **Badger Bridge on Poets Walk – Grant related works**
Update – 1st May 2020 – Bridge is useable. NSC are awaiting Secretary of State approval and funding for improvements
Information received - 9th June 2020 – Urgent repair carried out by NSC to a deck board piece on Badger Bridge, completed on 10th June 2020 – email to Committee members on 12th June 2020.
- **Victorian Shelter – Clevedon Seafront**
The shelter paintwork needs refreshing and replacement of the windows with a non-breakable material – further investigations to be conducted by NSC
- **Bandstand – Clevedon Seafront**
The paintwork on the Bandstand ceiling requires attention
Update - 1st May 2020 – NSC Officer advised that painting of the Bandstand ceiling to go ahead and to be paid for by NSC.
- **Green Open Space between The Leys and The Tynings**
Update - 12th June 2020 - NSC Streets & Open Spaces team to engage Community Payback team to complete the work to the overgrown brambles etc.
