Mr Harrison reported that the Environment Agency regularly clear the river of weeds etc which are left on the river bank. The Land Yeo Friends (LYF) then removes the litter. Every year it is noticeable that the worst accumulations of plastic and tins are adjacent to bridges and in particular the bridge off Strode Road towards the South Clevedon Playing Field (Penny Field). The LYF had requested a bin in this location some time ago and asked that this request could be re-considered. It was understood that litter bins in the town are the responsibility of NSC.

TEA/18/727 TO RECEIVE MINUTES OF MEETING OF THE SUB-COMMITTEE FOR SALTHOUSE FIELDS TENNIS COURTS HELD ON;

The minutes of the meeting held on 10th November 2017, 8th December 2017 and 13th December 2017 had been circulated to all Councillors and were received and noted. These meetings had been held following the award offer from Sport England and the requirement that the re-surfacing works be undertaken or at least commenced in this financial year.

A report on the tenders had been circulated to all Councillors. Five companies had tendered for this work; copies of the tender documents are available in the Town Council Office. The Sub-Committee recommended acceptance of the lowest tender. The Sub-Committee Chairman confirmed that the work of this company is of good standard.

RESOLVED: proposed and seconded vote: 8 for 0 against; To ask Council to ratify acceptance of the lowest tender for the re-surfacing of the tennis courts which now included chasing out/feathering down the new asphalt to edgings and a better quality asphalt at a reduced cost. Total £29,830 plus VAT.
