#### 17/730 **DECLARATIONS OF INTEREST**

There were no formal declarations of interest on items on the agenda.

### RECEIVE THE BUDGET RECOMMENDATION BY THE FINANCE & GENERAL 17/731 **POLICY COMMITTEE**

A copy of the Finance & General Policy Committees recommendation had been circulated to all members with the agenda. The Chairman reminded members of the robust nature of the procedure to set the budget in that each committee discusses and agrees its budget, the details of which are included in the minutes, those minutes approved by the Council and that the budget in total is then discussed at length by the F & GP committee giving all members opportunity to input into that discussion and raise any issues or concern prior to the Precept meeting.

It was proposed, seconded and REFUSED by 13 votes to 1 that the Council should take £30,000 from the general reserves to pay off part of the Public Works Loan.

Members discussed in great depth the level of reserves held by the Council; they noted the recommended minimum level of reserves as specified by the auditors, who had not queried the Council's reserves in the last 8 years. Comment was made that the Council had a duty to keep its costs under review and ensure that money is well spent; it was noted that the budget and costs are reviewed at every meeting by the individual committees, and the FGP Committee acting in a scrutiny role. Comment was made about the amount of grants awarded, it was noted that the Council had a criteria and procedure for the awarding of grants and that any discussions should be made during the relevant meeting.

It was **AGREED** to hold a special Finance & General Policy meeting in August/September to discuss the 5 year budget and to give guidance to the Committees for the 2018/2019 budget.
